

INTERNSHIP AGREEMENT

Part One:

I,, upon acceptance of the internship position offered by Sponsors for Educational Opportunity London, agree to (please indicate that you have read by ticking each statement below):

Withdraw any pending internship applications for the Summer of 2007. By signing this agreement, I understand that I am obligated to participate in the SEO Investment Banking Internship Programme of 2007.

Attend SEO training(s) prior to commencement of my internship. One of these trainings will take place on the 23rd of June, the second will take place on a date TBD in the spring.

Establish and maintain at least weekly contact with my SEO mentor during the period of the internship. I will also participate in at least one event organised by my mentoring team.

Participate in on-line forums and utilise internet resources provided by SEO.

Maintain at least weekly contact with the SEO office during the period of the internship. I will treat as urgent all correspondence from SEO staff and mentors.

Understand that my performance in all aspects of the programme will be evaluated and recorded throughout the course of the internship. Remember SEO is not just about you, but about your commitment to the SEO Community.

Attend all SEO seminars, events, and meetings.

I fully understand that I am obligated to attend all SEO functions, as they are a vital component of the internship programme. If work obligations make it impossible to attend, I will always notify the SEO office immediately, and at least three hours before the event.

Honour all oral and written contracts and agreements with SEO sponsor firms. I understand that, at the end of the internship, if I receive and accept a full-time offer from a bank I must not renege on that offer. Additionally, once I accept any offer, verbally or by written contract, I must withdraw all other applications.

Participate in recruitment for the SEO class of 2008 and be an ambassador for SEO at my University. I understand that SEO hopes that as an alumnus I will feel compelled to prioritise, throughout my life, both giving back to SEO and benefiting from SEO's global alumni community.

Be available to complete a full internship (dates are to be confirmed but will be from the last week of June to the end of the second week of September)
